

CANR Curricula and Courses Committee
Minutes (Final Approved)
October 1, 2010

I. Call to order: The meeting was called to order at 2:09 pm. Members present were Marilyn Altobello, Rhonda Brownbill, Mike Darre, George Elliott, Cameron Faustman, Sal Frasch, Susan Gregoire, Pat Jepson, Gary Kazmer and Mark Rudnicki.

II. The Minutes of September 17, 2010 approved with minor revisions.

III. Old Business:

A. Revise MT 4366 Phlebotomy Laboratory. Effective Spring 2011 CANR CC 10-11-11 tabled from Sept 17, 2010 meeting. It was moved to remove from the table and accept the revisions:

MT 4366 Phlebotomy Laboratory

Both semesters. One credit. Prerequisite: To enroll in the course the student must earn an "S" in MT 3365. Open only to Medical Technology majors; other with consent of medical Technology Program Director. Students taking this course will be assigned a final grade of S (satisfactory) or U (unsatisfactory).

Application of the theory and techniques learned in MT 3365 to the clinical laboratory setting. Understanding workflow, scheduling, teamwork, and quality assurance in the general laboratory environment.

Revised catalog copy: (*prerequisite change*)

MT 4366 Phlebotomy Laboratory

Both semesters. One credit. **Prerequisite or corequisite: MT 3365.** Open only to Medical Technology majors; others with consent of the Medical Technology program Director. Students taking this course will be assigned a final grade of S (satisfactory) or U (unsatisfactory).

Performance of venipuncture and skin puncture techniques. Understanding workflow, scheduling, teamwork, and quality assurance in the general laboratory environment.

B. Pat Jepson brought up the issue about students getting/taking 2Q and 2 Science courses as a CANR requirement as well as a University General Education requirement. Pat brought a draft of some language for how this will be put into the catalog. She will refine the language, add some historical background to the motion and send it to the departments for review.

C. The transfer student requirements for admission to the NUSC major were discussed again. (CANRCC 9-10-131). It was originally approved with some minor changes in the text but point # 3 was dramatically changed without a second approval by the CANR CC committee.

Students not admitted to the University as Nutritional Sciences majors may petition into this major during the first two weeks of each semester. The following petition requirements must generally be met for consideration of a major change into the Nutritional Sciences major:

1. Earned at least a C in CHEM 1124Q or CHEM 1127Q and CHEM 2241 or CHEM 2243
2. Earned at least a B in NUSC 1165
3. Earned a cumulative GPA of 2.5.

After further discussion it was returned to the department for approval of the following suggested changes:

1. Earned at least a C in CHEM 1124Q or CHEM 1127Q and a C- in CHEM 2241 or CHEM 2243.

D. It has been proposed to Drop the Aquaculture Minor. CLAS has approved the proposal. We are awaiting approval from ANSC and ARE to drop the minor, since they both have courses listed. ARE approved dropping the minor on 9/29/10. We await ANSC approval.

IV. New Business

A Allied Health moved to approve the following actions:

1. Add: AH 4240W and AH 4241 as program and graduation requirements under the 36-credit major group A category to satisfy the “W in the major” requirement for the Allied Health Sciences major for the Standard Plan, Health Sciences and Health Promotion Sciences concentrations. Effective Fall 2011.

4. Revise: Courses used for Allied Health Sciences concentration in Health Sciences Related Cognate Area (group B of major) Effective Spring 2011

Current Catalog:

Group B: A minimum of 18 credits in **Related Cognate** course work selected based on the student’s interest, ability, and that speaks to the student’s career goals and interests approved by the advisor and department head.

Revised Catalog:

Group B: A minimum of 18 credits in **Related Cognate** course work selected based on the student’s interest, ability, and that speaks to the student’s career goals and interests approved by the advisor and department head. **Courses used cannot also be used to meet group A requirements. Courses used to meet the Health Sciences concentration related cognate group B must be from the following subject codes: AH major/Health Sciences concentration Group A-3 courses (not used to meet that requirement) BIOL, CHEM, MCB, PHYS, PNB. Other courses may be used with advisor and department head approval.**

5. Revise: Additional Degree and Double Major review procedure. Effective Spring 2011. Add the following catalog copy:

Students who apply to the Allied Health Sciences major as a second major for additional degree or double major will be subject to department review and admission decision consistent with the admission requirements for students petitioning to the major as a primary major.

6. Revise: Regional Readmission Applicants Review Process. Effective Spring 2011 Add the following catalog copy:

Regional campus readmission applicants to the AHS major will be reviewed for admission consistent with the procedure applied to current non-AHS students petitioning to the major.

7. Revise: Petition process to the AHS major. Effective Spring 2011 Add the following catalog copy:

Students who petition to the AHS major with admission requirement coursework in transfer must provide the department with an official transcript as part of their petition documentation.

Admission – General

Freshmen are admitted into the Department of Allied Health Sciences as Allied Health Sciences (AHS) majors. Students are advised in the Department of Allied Health Sciences. During the spring of their sophomore year or after completion of a minimum of 45 credits, students may remain an Allied Health Sciences major, may further define their major by petition into a concentration within the Allied Health Science major, or apply to a Professional program (admission to a concentration within the AHS major or to a professional program is not automatic; refer to respective program admission information).

Students not admitted to the University as Allied Health Sciences majors may petition into this major during the first two weeks of each semester (does not apply to professional program application; see professional program admission information). **Students who apply to the Allied Health Sciences major as a *second major* for additional degree or double major will be subject to department review and admission decision consistent with the admission requirements. University readmission applicants who declare the AHS major will be subject to department review and admission decision consistent with the procedure applied to current non-AHS students petitioning to the major. Students who petition to the AHS major with admission requirement coursework in transfer must provide the**

department with an official transcript as part of their petition documentation. The following petition requirements must be met for consideration of a major change into the Allied Health Sciences major:

1) A minimum math and science GPA of 2.2 with no more than one grade less than a C- .

2) Math and Sciences GPA must include at least one of each of the following:

a. CHEM 1122 or 1124Q or 1127Q

b. BIOL 1107 or 1108

c. MATH 1040Q or 1060Q or 1125Q or higher; or STATS 1000Q or 1100Q
