**I. Welcome and Call to Order**

**III. Old Business:**

A. **REVISE:** Admission requirements for Allied Health Sciences Majors. Effective immediately.

It was moved to remove from the table.

**Current catalog description:**

Admission – General

Freshmen are admitted into the Department of Allied Health Sciences as Allied Health Sciences (AHS) majors. Students are advised in the Department of allied Health Sciences. During the spring of their sophomore year students may remain an Allied Health Sciences major, may further define their major by petition into a concentration within the Allied Health Science major, or apply to a Professional program (admission to a professional program or to a concentration within the AHS major is not automatic; refer to program admission information).

**Revised Catalog description:**

Admission – General

Freshmen are admitted into the Department of Allied Health Sciences as Allied Health Sciences (AHS) majors. Students are advised in the Department of Allied Health Sciences. During the spring of their sophomore year or after completion of a minimum of 45 credits, students may remain an Allied Health Sciences major, may further define their major by petition into a concentration within the Allied Health Science major, or apply to a Professional program (admission to a concentration within the AHS major or to a professional program is not automatic; refer to respective program admission information).

**Students not admitted to the University as Allied Health Sciences majors may petition into this major during the first two weeks of each semester (does not apply to professional program application; see professional program admission information).**

The following petition requirements must be met for consideration of a major change into the Allied Health Sciences major:

- 1) A minimum math and science GPA of 2.2 with no more than one grade less than a C- .
- 2) Math and Sciences GPA must include at least one of each of the following:
  - a. CHEM 1122 or 1124Q or 1127Q
  - b. BIOL 1107 or 1108
  - c. MATH 1040Q or 1060Q or 1125Q or higher; or STATS 1000Q or 1100Q

- A. Allied Health – Allied Health moved to approve the following:
  1. **ADD:** INTD 3995 Introduction to Public Health course for the Fall 2010 semester as a second time offering.

After lengthy discussion on the pros and cons of offering this course as INTD rather than AH the committee voted to approve a second offering.

2. **REVISE:** AH 3121: Immunology for the Medical Laboratory Sciences. (Change the recommended preparation courses to pre-requisite requirements to include MT 3130 or MCB 2610 which may be taken concurrently, effective Fall 2010.

Current Title and Catalog Copy:

AH 3121 Immunology for the Medical Laboratory Sciences (Formerly offered as MLS 3121). Second semester. Three credits. Three hours of lecture. Recommended preparation: MCB 2610 which may be taken concurrently. Open to students in the following majors: Allied Health Sciences, Diagnostic Genetic Sciences and Medical Technology; open to juniors or higher. Mechanisms of innate and acquired immunity, antigen-antibody interactions, function of the human immune system in normal and diseased states.

Revised Title and Catalog Copy: (change recommended prep to prerequisite)

AH 3121 Immunology for the Medical Laboratory Sciences (Formerly offered as MLS 3121). Second semester. Three credits. **Prerequisite:** MT 3130 or MCB 2610 which may be taken concurrently.

Open to students in the following majors: Allied Health Sciences, Diagnostic Genetic Sciences and Medical Technology; open to juniors or higher.

Mechanisms of innate and acquired immunity, antigen-antibody interactions, function of the human immune system in normal and diseased states.

3. **ADD:** GPAH 5351. Contemporary Nutrition Issues and Research. Effective Fall 2010.

Proposed catalog copy:

GPAH 5351. Contemporary Nutrition Issues and Research

First semester. Three credits. Open to dietetic interns and others by consent of instructor.

Critical thinking and application of research to contemporary issues in food and nutrition applied to clinical nutrition and community/public health nutrition.

Learning occurs through classroom discussions, self-exploration through reading and applying scientific studies to issues, and participation in a research project.

1. **ADD:** MARN/NRE 2693 Reef Fishes –

After discussion about the number of credits being offered and the time allowed during the May session, it was moved to table the motion until further information on how many hours of classroom, lab and discussion are required for a 3 credit May session course. A syllabus was also requested.

1. **REVISE:** PVS 5394 Veterinary Pathology Seminar (Increase from 1 cr to 2 cr)

New Course Description:

PVS 5394 Veterinary Pathobiology Seminar (PVS 312) 2 credits. Seminar. Blinded examination of gross and histology lesions with emphasis on

lesion recognition, description and disease diagnosis, followed by group discussion of each case.

2. **ADD:** PVS ~~5094~~ 5594 Current Veterinary Pathology Literature

New Course Description:

PVS ~~5094~~(5594) Current Veterinary Pathology Literature. 1 credit.

Seminar. Instructor consent required.

Detailed study of current veterinary pathology literature, with particular emphasis on lesions and mechanisms of disease.

3. **ADD:** PVS 5392 Practicum in Veterinary Anatomic Pathology

New Course Description:

PVS 5392 Practicum in Veterinary Anatomic Pathology

3 credits. Practicum. Open only to veterinarians accepted into the residency program in veterinary pathology. Service-based learning of veterinary anatomic pathology through gross and histologic evaluation of necropsy and biopsy case material by direct review with faculty pathologists.
