2) REVISE: ARE 4991 Resource Economics Internship. Change the title and catalog copy. Effective Spring 2017 (Emma and Tom)

**Current Title and Catalog Copy:**

ARE4991. Resource Economics Internship (Formerly offered as ARE 4091.) Variable credits (1-6). Repeatable for a total of six credits. Prerequisite: Open only to junior and senior students majoring in Resource Economics who have demonstrated outstanding academic ability and possess excellent professional potential; requires Independent Study Authorization with consent of department head and advisor.

Provides students with a meaningful experience in a formalized agribusiness or natural resources program under supervised conditions. Each student taking this course must submit a formal written report for evaluation and meet all other course requirements as specified by the instructor.

**Revised Title and Catalog Copy:**

ARE 4991. Professional Internship (Formerly offered as ARE 4091.) Variable credits (1-6). Repeatable for a total of six credits. Prerequisite: Open only to junior and senior students majoring in Applied Resource Economics who have demonstrated outstanding academic ability and possess excellent professional potential; requires Independent Study Authorization with consent of department head and advisor.

Provides students with a meaningful experience in a formalized applied resource economics program under supervised conditions. Each student taking this course must submit a formal written report for evaluation and meet all other course requirements as specified by the instructor.

**Comments:** Fix the syllabus to include a better description of how the students will be assessed and graded for their participation in the internship. Also consider adding information for the businesses where your students will intern about UConn's policy on Sexual Harassment, and Discrimination.

Prerequisite: ARE 1150 or ECON 1200 or ECON 1201; MATH 1071Q or 1110Q or 1126Q or 1131Q; and STAT 1000Q or 1100Q. Not open to students who have passed ARE 4464. Case studies to present the process by which organizations can best optimize their programming, topics on performance indicators, the logical framework and results matrix, sample design, impact evaluation methodologies and project appraisal.

**Proposed Title and Catalog Copy:**

KINS 6106. 3 credits. Qualitative Research Methods.

Introduction of the role of qualitative research in healthcare and exercise science. Major approaches used in conducting qualitative research and the application of these methods to problems and phenomena in healthcare and athletic training will be examined. The emphasis of the course is on the developmental process prior to collection, collection, management, analysis, and interpretation of qualitative data. Exploration and application of topics such as sampling, interviewing and observation techniques, data analysis methods, and reporting of qualitative research will be addressed. Evaluation and critique of research studies utilizing qualitative methods will also be examined.
